3. Short description of the intended use: Tell your reasons for wanting to study the collections of the Sámi Museum. We ask you to explain the intended use of the material so that we can meet the needs of our customers and assess whether we can grant access to our material.

By scientific research we mean research that is at least at the level of a doctoral thesis. Exception applies to the theses of the culture and traditional program students at the Sámi Education Institute and the other universities and vocational schools in the Sámi Area.

- **4. Photographing, copying and/or publishing material:** Mark here if you want to photograph or copy material. If you want to publish photographs, you need to append an agreement concerning the publication of photographs in this application; our staff will provide you more information on this.

As concerns research projects, we require that the Sámi not be only an object of research but rather an active player; we also require that research strengthen the right of the Sámi to self-determination and their collective rights to their cultural heritage as an indigenous people.

Therefore, we want to see how granting permission to use material in research will serve the Sámi or stakeholders in the Sámi Area, and to have a look at the ethical informed review on the intended use of the material, if the request for a review has not been submitted to the Sámi Parliament or a comparable stakeholder representing the Sámi community.

- **8. Commitment:** The ones given research permission commit themselves to use the accessed information only for the purpose for which permission has been granted, to not transfer copies to other players, to observe the conditions of permission, and to treat the material properly in accordance with the guidelines provided by the Sámi Museum Siida.
- **9. Decision:** The granting of research permission will be based on the information provided in this application, so we warmly recommend filling in the application carefully. The decision will be final.
